Message from Dean Linda Ammons

If you will be engaged in law-related employment or internship opportunities, I am sure you will return in the fall with a great appreciation of what you have learned in your classes, and what you still have to learn. Those of you studying abroad, have a wonderful time and spread the news about Widener Law. Good luck, and come back in August with your batteries recharged and with a renewed dedication to your legal studies.

The Martin Luther King Semester of Service Project offers all members of the law school community an opportunity to perform both hands-on labor and pro bono legal services for those in need.

Students who perform at least twelve (12) hours of combined service before the end of the semester are designated "MLK Service Fellows" and are recognized at the Student Awards Ceremony. Students also earn credit towards *pro bono distinction*.

Participants perform at least 5-8 hours of charitable labor and 5-8 hours of law-related service for a combined total of at least 12 hours.

IMPORTANT INFORMATION

FINAL EXAMINATIONS

As final examinations approach, all students should take a few minutes to review the Law School rules relating to examinations. These rules may be found in §607-609 of the *Academic Code* and §203-205 of the Dean's Office Regulations.

According to §607 (f)(1) of the Code, all examinations are graded anonymously. Students should not discuss the examination process, including the possibility of exam deferral or exam accommodation with faculty members. Any attempt by a student to identify himself/herself to a professor by placing notes or messages on an examination or exam booklet compromises the anonymous grading system. All questions should be directed to Associate Dean of Student Affairs office or the Registrar's Office. Any compromise of the anonymous grading system by a student constitutes a violation of the Code of Conduct and could result in suspension or expulsion.

Permission to defer an examination will be granted only in extreme cases. Students should refer to the guidelines. Emergency deferrals will be granted to those students who, for medical reasons, are unable to sit for an examination when scheduled. A student who becomes ill and cannot take an examination when scheduled must call the Registrar's Office before the examination begins. If that student cannot appear in person or call the Registrar, he/she may miss the exam and apply for a deferral. An application for this type of deferral must be made within 48 hours of the original exam date and in no event later than the last day of regularly scheduled exams. The student must also provide the Registrar's Office with a letter from the attending physician which confirms that the student was unable to sit for the examination due to illness. Students who begin an examination and leave due to illness may not make up the examination on the makeup day. The examination must be retaken at the end of the next semester in which the course is offered.

Anonymous numbers Anonymous numbers must be placed on all examination booklets and on the examination itself. In the unlikely event you forget to put your anonymous number on your papers before time is called, you may do so at the proctor's table when you turn in your exam. If you continue to write after the proctor has told you to stop, your examination number and the fact that you did not stop when told will be reported to the Registrar's Office and may ultimately be reported to the Office of Student Affairs.

Open book exams You may bring into an open book exam only those items designated by the professor. If you are in doubt as to what can be brought into the exam, check with your professor before the examination.

Scrap paper Scrap paper will only be permitted in an examination if the professor has specifically told the Registrar that it will be permitted. The proctor will distribute scrap paper to you during the examination.

Lavatory breaks You are reminded that the honor code applies during the entire exam and a lavatory break does not mean there is a break in the honor code rules.

Student ID Finally, remember to bring your *student ID* to each of your examinations. **STUDENTS MUST BE POSITIVELY IDENTIFIED BY THE REGISTRAR OR PROCTOR BEFORE SITTING FOR EACH EXAM.**

Students are reminded that the **Student Code of Conduct §202(1)** requires you to report all Code of Conduct violations.

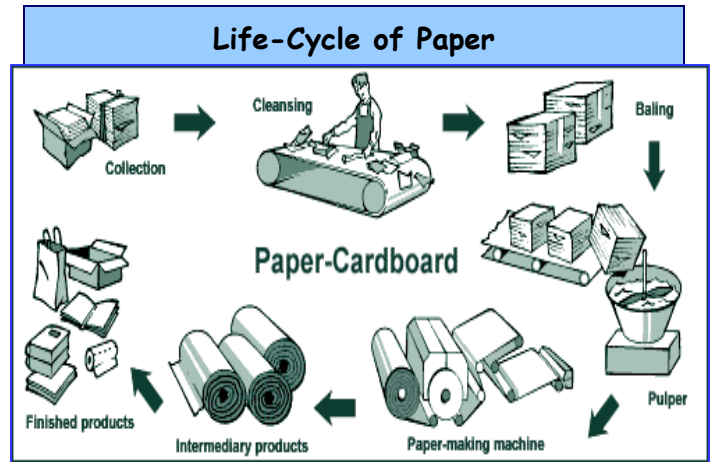
RECYCLING NEWS

BY THE NUMBERS.....

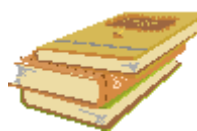

Skills Not Taught in Law School: What Associates Need to Know

Kimberly Egan, a partner in the DC office of DLA Piper, offers a list of fifteen attributes that drive the professions's most successful attorneys. These skills are not taught in law school, but they can and should be developed. Here are tips Nos. 12 & 13:

12. Time Management

Everything takes longer than expected. For research and writing projects, a good guide is the "double it to the next power" rule. For example if someone says that a project will take two hours, it actually will take four days. Good layers give themselves extra time in case things go wrong. Good lawyers are prepared for the messengers to get stuck in traffic, trains and planes to get delayed and computers to malfunction. Developing good time-management skills is especially important when juggling multiple clients and when more than one deadline occurs on the same day. Learning how to do it early is critical.

13. Diligence

The most effective new lawyers turn in completed work product, not "drafts." To senior lawyers, "draft" does not mean "work in progress," or work completed "so far." Proofreading is critical. Running spellcheck is not a substitute for proofreading. Proper grammar is not a matter of "style." And no assignment in a law firm is beneath anyone. There is no magic band of elves that comes in at night and does all the little tasks that a busy lawyer would rather not do.
