Delaware Supreme Court Oral Arguments

Ruby R. Vale Moot Courtroom Wednesday, April 16, 2014

548, 2013 Mammarella v. Evantash

(Appellant's counsel: Ben Castle) (Appellee's counsel: Dennis Ferri; Ryan Keating)

<u>Facts</u>: The plaintiff filed a medical negligence action asserting that the defendants'six-month delay in diagnosing her malignant breast tumor: (i) caused a 33% increase in the size of the tumor, which increased her risk of death by 17%; (ii) eliminated radiation as a potential treatment; (iii) forced her to undergo chemotherapy; and (iv) caused her psychological fear and dread. The Superior Court (Rapposelli, J.) granted judgment as a matter of law under Rule 50 (a)(1) after finding that no reasonable juror could find in plaintiff's favor on the issue of medical causation.

<u>Issue</u>: Plaintiff contends that the Superior Court erred in granting judgment as a matter of law.

- (i) failing to request an accomplice credibility instruction under Bland;
- (ii) failing to request a jury instruction regarding the significance of Harris' guilty plea;
- (iii) failing to appeal the Superior Court's denial of defense counsel's request to empanel a new jury after Harris' plea; and
- (iv) failing to object to the State's improper vouching.

COURTROOM PROTOCOL

FOR ALL PERSONS ATTENDING ORAL ARGUMENTS

- All persons must submit to a security check to enter the courtroom.
- No backpacks or purses are allowed in the Vale.
- No cell phones, cameras, recording devices or electronic devices are allowed in the courtroom. (Exception: credentialed media representatives may make satisfactory advance arrangements with the Clerk consistent with the Court's media access order).
- No food or drink will be allowed in the courtroom.
- No one may enter or exit the courtroom after an argument has started. Entry or exit <u>between</u> arguments is permitted.
- The Court requests the full attention of everyone during the argument.
- Anyone who creates a disturbance must leave the courtroom and may not return. (Example: chronic coughing)
- No outward display of emotion may be made during the argument.



2014 MARTIN LUTHER KING JR. SEMESTER OF SERVICE

The Public Interest Resource Center (PIRC) and the Public Interest Law Alliance (PILA) invite the Law School Community to participate in the Eight Annual Martin Luther King, Jr. Semester of Service.

12 weeks/12 hours

Participants are asked to perform at least twelve (12) hours of community service in designated "Semester of Service" projects before the end of the semester. Successful participants will be designated "MLK Service Fellows" and will be recognized at the Student Awards Ceremony and at Graduation. Students will also earn credit towards pro bono distinction.

To become an MLK Service Fellow, perform at least 12 hours of service through the following projects.

2014 SERVICE PROJECTS

Medical-Legal Project: Through partnership with Community Legal Aid Society, Inc., participants will conduct "legal needs" surveys of patients at Federally Qualified Health Centers in Delaware. Participants will visit the centers—likely in teams of two or three—and assist patients in completing surveys designed to measure the scope and character of unmet legal needs, needs that may have direct relationship to patient health. Training at the School of Law (or via on-line video).

Training: March 18 at 12:00 noon (or via on-line video).

Field Work: Weeks of March 31, April 7, April 14, April 21.

Pro Bono/Semester of Service Credits: 2 hours training; 4 hours field work (per survey session).

Teaching Project: Through partnership with the Delaware Law Related Education Center, participants will teach part of a curriculum on "Desegregation in Delaware" in Delaware high school classes. Participants will visit the classrooms–likely in teams of two–to present a pre-prepared ninety minute lesson on *Parker v. University* of *Delaware*, the 1950 case ordering the desegregation of the University of Delaware. Training at the School of Law (or via on-line video).

Training: March 25 at 12:00 noon (or via on-line video).

Field Work: Weeks of March 24, March 31, April 7.

Pro Bono/Semester of Service Credits: 2 hours training; 4 hours field work (per class).



SUMMER 2014 INTERNSHIP POSITIONS IN THE ENVIRONMENTAL LAW CLINIC

Widener's Environmental and Natural Resources Law Clinic is now accepting applications for summer intern positions. The Clinic seeks to have 4 interns assist in handling pending and new Delaware (and possibly Harrisburg) Office matters during the summer break. Interns will work under the direct supervision of Clinic Director Prof. Kristl on a variety of projects, which may include:

- * research and writing of legal memos dealing with issues in pending matters;
- * drafting client letters, briefs, motions, and other documents for use in pending matters;
- * updating and preparing new materials for the Clinic's pages on the Environmental Law Center's website
- * preparing for and attending client meetings, public hearings, and court hearings
- * responding to inquiries on the Widener Environmental Help Line.

Projects will be designed with individual experience and capacity in mind (i.e., we try hard to make sure you're not in over your head!)

Intern positions are available for Regular and Evening Division students who, by the time the internship starts, have completed at least 1 year here at Widener

This can be a great chance to gain real, practical experience in general and to check out the Environmental Clinic to see if it might be right for you to take for credit later in your law school career.

Requirements

Applicants must submit their resume and interview with the Clinic Director and Staff Attorney. Applicants accepted into the program must agree to do the following during the summer (May 31 – August 4):

- * work at least 10 hours a week on Clinic matters (need not be done in the Clinic space)
- * stay in regular contact with the Clinic Director
- * meet reasonable deadlines set by the intern and Clinic Director
- * maintain confidentiality and comply with all applicable rules of professional conduct

Application Deadline

Interested students must submit their resume and a short statement of why they are interested in the position to the Clinic Director by email (ktkristl@widener.edu) no later than 6:00 p.m. on TUESDAY APRIL 16, 2014. Applications submitted after the deadline will not be considered unless the positions have not been and cannot be filled by those applying before the deadline. Interviews will take place in Professor Kristl's Clinic office, by phone or by Skype. When submitting your resume, please indicate which dates and times you would be available to meet with the Clinic Director for an interview. Internships will be awarded by April 30.

IMPORTANT INFORMATION

REGARDING EXAMS

All Dean's Action Requests to defer an exam must be submitted to the Registrar's Office no later than **Friday, April 25th.** Any request to reschedule an exam received after that date (other than an emergency request) will be automatically denied. Please remember that exam conflicts created by your own course selection are NOT deferrable.

FINAL EXAMINATIONS

As final examinations approach, all students should take a few minutes to review the Law School rules relating to examinations. These rules may be found in §607-609 of the Academic Code and §203-205 of the Dean's Office Regulations.

According to §607 (f)(l) of the Code, all examinations are graded anonymously. Students should not discuss the examination process, including the possibility of exam deferral or exam accommodation with faculty members. Any attempt by a student to identify himself/herself to a professor by placing notes or messages on an examination or exam booklet compromises the anonymous grading system. All questions should be directed to Associate Dean of Student Affairs office or the Registrar's Office. Any compromise of the anonymous grading system by a student constitutes a violation of the Code of Conduct and could result in suspension or expulsion.

Permission to defer an examination will be granted only in extreme cases. Students should refer to the guidelines. Emergency deferrals will be granted to those students who, for medical reasons, are unable to sit for an examination when scheduled. A student who becomes ill and cannot take an examination when scheduled must call the Registrar's Office before the examination begins. If that student cannot appear in person or call the Registrar, he/she may miss the exam and apply for a deferral. An application for this type of deferral must be made within 48 hours of the original exam date and in no event later than the last day of regularly scheduled exams. The student must also provide the Registrar's Office with a letter from the attending physician which confirms that the student was unable to sit for the examination due to illness. Students who begin an examination and leave due to illness may not make up the examination on the makeup day. The examination must be retaken at the end of the next semester in which the course is offered.

Anonymous numbers must be placed on all examination booklets and on the examination itself. In the unlikely event you forget to put your anonymous number on your papers before time is called, you may do so at the proctor's table when you turn in your exam. If you continue to write after the proctor has told you to stop, your examination number and the fact that you did not stop when told will be reported to the Registrar's Office and may ultimately be reported to the Office of Student Affairs.

Open book

You may bring into an open book exam only those items designated by the professor. If you are in doubt as to what can be brought into the exam, check with your professor before the examination.

Scrap paper

Scrap paper will only be permitted in an examination if the professor has specifically told the Registrar that it will be permitted. The proctor will distribute scrap paper to you during the examination.

You are reminded that the honor code applies during the entire exam and a lavatory break does not mean there is a break in the honor code rules.

Finally, remember to bring your <u>STUDENT ID</u> to <u>each</u> of your examinations. **STUDENTS <u>MUST</u> BE**POSITIVELY IDENTIFIED BY THE REGISTRAR OR PROCTOR BEFORE SITTING FOR EACH EXAM.

ONLY WIDENER STUDENT ID IS ALLOWED

Students are reminded that the **Student Code of Conduct §202(I)** requires you to report all Code of Conduct violations.
