### EXAM PREPERATION

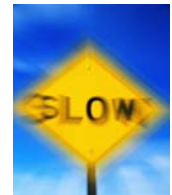
To help you prepare for your finals, the library has collected a number of study aide resources that may be useful to you. A popular set used by many students is the *Examples & Explanations Series*. This set combines text to explain legal doctrines with exercises to give practice in applying the concepts. To view a list of available titles, do a key word search in the library catalog for “examples and explanations.” The library staff would remind you these study materials have shortened check-out times, usually for three days, to ensure many students will have the opportunity to use them. Please be courteous to your classmates and make sure to check the due-date on your library resources and return them on-time.

To help you better prepare for your finals, many of the Harrisburg faculty toward the end of the semester will place old law exams on reserve in the library. ***Nuremberg: Its Lesson For Today*** shows how the four allied prosecution teams — from the United States, Great Britain, France and the Soviet Union — built their case against the top Nazi leaders. As documented in the film, the trial established the "Nuremberg principles," laying the groundwork for all subsequent prosecutions, anywhere in the world, for crimes against the peace, war crimes, crimes against humanity, and genocide.

This film, originally made for the U.S. Department of War in 1948, was widely shown in Germany following WWII, but suppressed in the U.S. because it showed the U.S.'s new Cold War ally, Germany, in a bad light. More recently, the daughter of one of the original filmmakers, Sandra Schulberg, re-produced the film and is screening it throughout the country.

The film follows the structure of the trial, using the four counts of the indictment as its organizing principle. Cutting back and forth between original footage from the Nuremberg courtroom and the Nazis' own films, Schulberg reconstructs the prosecution's case and rebuts the defendants' assertions.

The film provides fascinating insights into the international response to the Holocaust after the end of the War as well as one of the seminal trials in history. It also provides a deeper understanding of, and appreciation for many of the participants, including Justice Robert Jackson, a Pennsylvania native, who, as many are aware, served as Chief US Prosecutor at the trial.

The film premiered in The Hague as the centerpiece of the Erasmus Prize ceremonies. In 2009, the Prize was awarded to Ben Ferencz, one of the original Nuremberg prosecutors, who is now 90, and to Antonio Cassese, first President of the International Tribunal for the former Yugoslavia and currently President of the Special Tribunal for Lebanon.

The original film was written and directed by Stuart Schulberg, and edited by Joseph Zigman, under the aegis of Pare Lorentz, chief of Film/Theatre/Music at the U.S. War Department, and completed by Schulberg in 1948, under the aegis of Eric Pommer, chief of the Motion Picture Branch of U.S. Military Government in Berlin.

The film makes extensive use of footage from *The Nazi Plan* and *Nazi Concentration Camps*, evidentiary films compiled under the supervision of Budd Schulberg, that were presented at the Nuremberg trial.

Schulberg Productions and Metropolis Productions now present the first complete 35mm picture and sound restoration of the U.S. Government's 1948 film about the first Nuremberg trial - the International Military Tribunal.
